

## **"Rolex Submariner Date" Sweepstakes**

### **OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF MONEY WILL NOT IMPROVE THE CHANCES OF WINNING. THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH ANY SOCIAL MEDIA PLATFORM, INCLUDING WITHOUT LIMITATION X (FORMALLY TWITTER), YOUTUBE AND INSTAGRAM FROM META ("SOCIAL MEDIA PLATFORM(S)").**

The "Rolex Submariner Date" Sweepstakes (the "Sweepstakes") is intended for legal residents of the United States of America ("USA") (excluding FL & NY), Canada, and the United Kingdom ("UK", excluding residents of Northern Ireland), and shall only be construed and evaluated according to applicable USA law, Canadian law, UK law, and applicable state/province law. Do not enter this Sweepstakes if you are not a USA, Canada or UK resident or are otherwise ineligible to enter in accordance with these Official Rules at the time of entry. The Sweepstakes is sponsored by Fanathem, Inc., 55 Madison Ave. Suite 400, Morristown, NJ 07960 (the "Sponsor").

NOTE: Winners of previous Fanathem Sweepstakes may continue to enter Fanathem-sponsored Sweepstakes. **Void where prohibited or restricted by law.** (For the avoidance of doubt, any references in these Rules to Entrants shall also include the Entrant who is deemed the Winner (as defined below)).

**AGREEMENT TO OFFICIAL RULES:** By participating, Entrants agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes. **HOW TO ENTER:** The Sweepstakes begins at 12:00:01 a.m. PDT on April 3, 2025 and ends at 11:59:59 p.m. PDT on April 11, 2025 ("Sweepstakes Period"). The Sponsor's database computer is the official time-keeping device for the Sweepstakes. Four (4) methods of entry are as follows:

1. **Via Online Purchase** – During the Sweepstakes Period, Entrants who make a purchase of the "Limited Edition Rolex Submariner Date Collectable" or "Limited Edition Rolex

Submariner Date (royalty-free) Digital Download" through the Sponsor's online shop at [www.fanathem.com](http://www.fanathem.com) (the "Website"), will automatically receive one (1) entry into the Sweepstakes.

NOTE #2: ANY FRAUDULENT ACTIVITY IN CONNECTION WITH THIS SWEEPSTAKES IS STRICTLY PROHIBITED. IT IS FRAUDULENT TO PURCHASE ITEMS TO OBTAIN ENTRIES WITH THE INTENT TO RETURN THESE ITEMS AFTER THE SWEEPSTAKES ENDS. By submitting an Entry via Instagram.com, each Entrant consents to receive from the Sponsor an Instagram comment, if applicable, an email notifying such Entrant that he/she is a potential Prize Winner. The Released Parties are not responsible for late, incomplete, delayed, undelivered, or misdirected entries. All entries become the exclusive property of Sponsor and will not be acknowledged or returned except as provided herein. By participating, you consent to Sponsor's and its agents' use of your personal information for the administration of this Sweepstakes, or in any other manner consistent with Sponsor's Privacy Policy, available at <https://fanathem.com/privacy-policy>.

**GENERAL CONDITIONS:** If for any reason the operation or administration of this Sweepstakes is impaired or incapable of running as planned for any reason, including but not limited to (i)

infection by computer virus, bugs, (ii) tampering, unauthorized intervention, (iii) fraud, (iv) technical failures, or (v) any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, without notice and award the Grand Prize (defined below) using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. **DRAWING AND NOTIFICATION:** The potential Grand Prize Winner will be selected in a random drawing conducted by the Administrator. The Grand Prize drawing will be conducted on or about April 17, 2025. Odds of winning the Grand Prize will depend on the total number of eligible entries received throughout the Sweepstakes Period. The potential Grand Prize Winner will be contacted by the Sponsor or Administrator via phone, email, and/or USPS mail.

**GRAND PRIZE:** There will be one (1) Grand Prize available. The Grand Prize Winner ("Winner"), upon the Administrator's confirmation of eligibility, will receive a 2024 Rolex Submariner Date (Black) ("Prize" or "Grand Prize"). Approximate retail value ("ARV") - \$14,999USD. All other expenses associated with Prize acceptance or usage not specifically mentioned herein are the responsibility of the Winner. The Prize will be awarded in "AS-IS" condition. Substitution, assignment or transfer of a Prize is not permitted, except by Sponsor, who reserves the right to substitute the Prize with another of equal or greater value. The Prize has no cash surrender value,

except where required by law.

**ADDITIONAL PRIZE CONDITIONS:** By accepting the Prize, the Winner agrees to release and hold harmless the Released Parties from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of the Prize.
