## "FG 42" Sweepstakes OFFICIAL RULES

## NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF MONEY WILL NOT IMPROVE THE CHANCES OF WINNING.

The "FG 42" Sweepstakes (the "Sweepstakes") is intended for legal residents of the contiguous United States of America ("USA") and shall only be construed and evaluated according to applicable USA law and applicable state law. **DRAWING AND NOTIFICATION:** The potential Grand Prize Winner will be selected in a random drawing conducted by the Administrator. Substitution, assignment or transfer of a Prize is not permitted, except by Sponsor, who reserves the right to substitute the Prize with another of equal or greater value.
